

## ***Data call: Data submission for landings of elasmobranch species (2005–2015) in support of the ICES fisheries advice***

---

### Scope of the Data call

ICES Member Countries are requested to provide landings from 2005-2015 and other supporting information for a list of elasmobranch taxa (Annex 1) with the aim of providing the 2016 advice and consolidate data for elasmobranchs as requested in the recent WKSHARKS in this extended data call.

ICES requests the data to be delivered by **13<sup>th</sup> of May 2016** to provide enough time for additional quality assurance prior to the WGEF (Working Group in Elasmobranch Fisheries) meeting.

*This Data call follows the principles of personal data protection as referred to in paragraph (16) of the preamble in Council Regulation (EC) No 199/2008.*

#### 1. Data submission

All ICES Member Countries having catch data on the requested taxa (see Annex 1) should submit data from the period 2005–2015 to ICES Secretariat via email ([accessions@ices.dk](mailto:accessions@ices.dk)). Data should follow the InterCatch SI format (see Annex 2) and should be reported by year, fleet as requested by WKSHARKS (see below) and ICES Division.

National coordinators for France, Ireland, Netherlands, Norway, Portugal, Spain and UK should liaise with their national WGEF members to ensure that additional fields, as indicated in the WKSHARKS report (ICES 2016), are completed prior to submission to [accessions@ices.dk](mailto:accessions@ices.dk). For other ICES Member Countries, data can be submitted directly to ICES.

**Data should be emailed with subject and filename as follows (country as ISO alpha-2):**  
**"2016 DC WGEF [country] landings"**  
**(example: 2016 DC WGEF ES landings)**

ICES Secretariat will forward the data files to the stock coordinator and the Working Group chair. Only one file per member state is required for all species. As elasmobranchs are often recorded at higher category level (annex 1) than species level, care should be taken to avoid double counting of landings.

#### 2. Fleet

Where practicable, 'fleet' data should be provided for the following categories: (i) beam trawl, (ii) all other bottom trawls (including otter and pair trawls), (iii) pelagic trawls, (iv) hooks and lines, (v) nets, (vi) seines and (vii) all other gears. If Member Countries are unable to provide data by these named gear categories, then data should be submitted at DCF Level 2 (see [2010/93/EU](#) Appendix IV).

#### 3. Areas

For taxa with catches inside and outside the NEAFC regulatory area catches taken inside or outside the NEAFC area should be identified by using the correct NEAFC area (e.g. specifying VIIk1, VIIk2 vs. VIIk only or specifying VIb1, VIb2, vs. VIb only).

Submitted data should include national landings for all elasmobranch species in FAO area 27 (by ICES Division), as well as national landings for FAO areas 34 (CYO, GUQ), 34 and 37 (POR, GAG, SMD, SDS, MPT, SDV), 21, 31 and 34 (BSH, SMA), and 21,31,34,37 (BSK, ALV, BTH, THR). Specifications and species code can be found in Annex 1.

#### 4. Units used

Landings: in tonnes (three decimal places).

Year must be entered as four digits, e.g. "2015".
